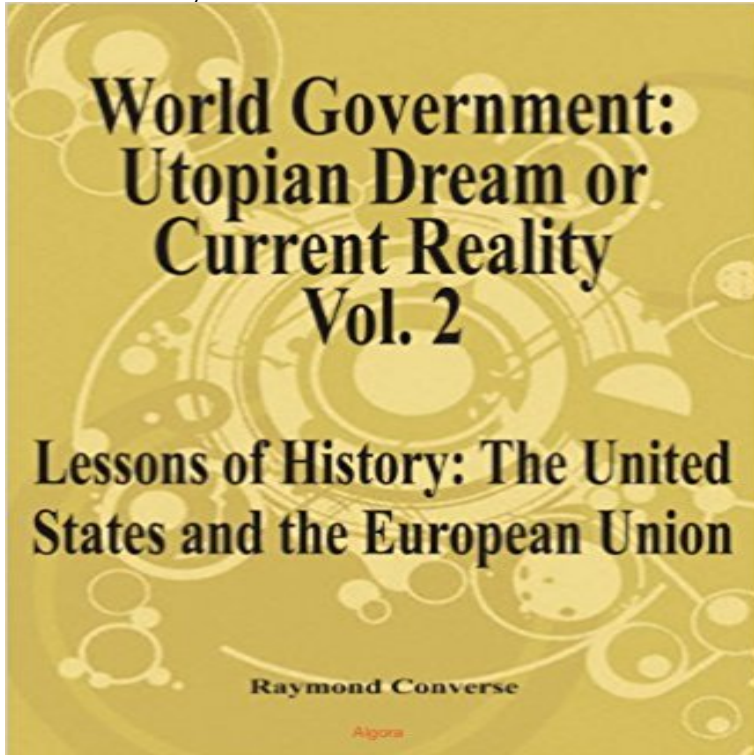


## World Government - Utopian Dream or Current Reality? Vol. 2, Lessons of History: The United States and the European Union



This book assumes that the world is moving inexorably, if in fits and starts, toward union. The author explores the implications such a unification will have for all global citizens, great and small, and considers some of the ways such a union might be managed for the greatest good. The author follows the evolution of the political system of the US, in particular analyzing the Declaration of Independence, the Constitution, and the Bill of Rights, to trace how and when the rights of the general government, States rights, and individual rights were addressed, and he draws comparisons and contrasts to the way the United Nations and the European Union have handled questions of national sovereignty vs. collective rights and obligations on the one hand, and human rights on the other. Indeed, the book doubles as a comparative study of the founding documents of the United States and the European Union. The author posits that a general disarmament will be a prerequisite to such a development, and he discusses the implications. Further, for such a union to succeed, he suggests all nations will either be representative democracies or will convert to the use of representative democracy within a reasonable time after joining the world union. As a natural consequence of these developments, the author suggests, any nation choosing not to join the world union will find its isolation unsustainable and will seek to join the union after all. Lastly, the author concludes that a meaningful liberal education is necessary to prepare individuals for their role as politically, economically, and socially informed citizens.
