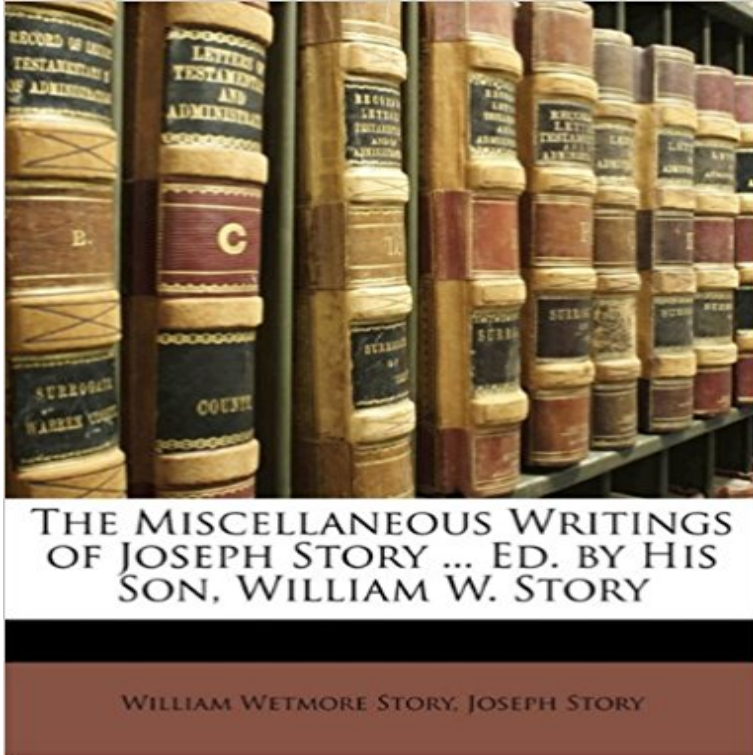


# The Miscellaneous Writings of Joseph Story ... Ed. by His Son, William W. Story
