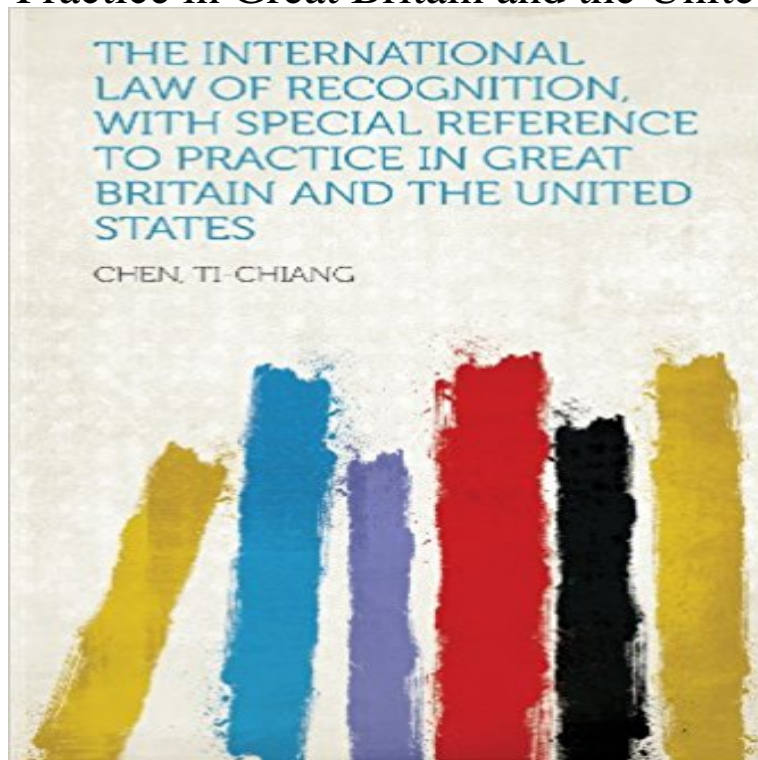


# The International Law of Recognition, With Special Reference to Practice in Great Britain and the United States
