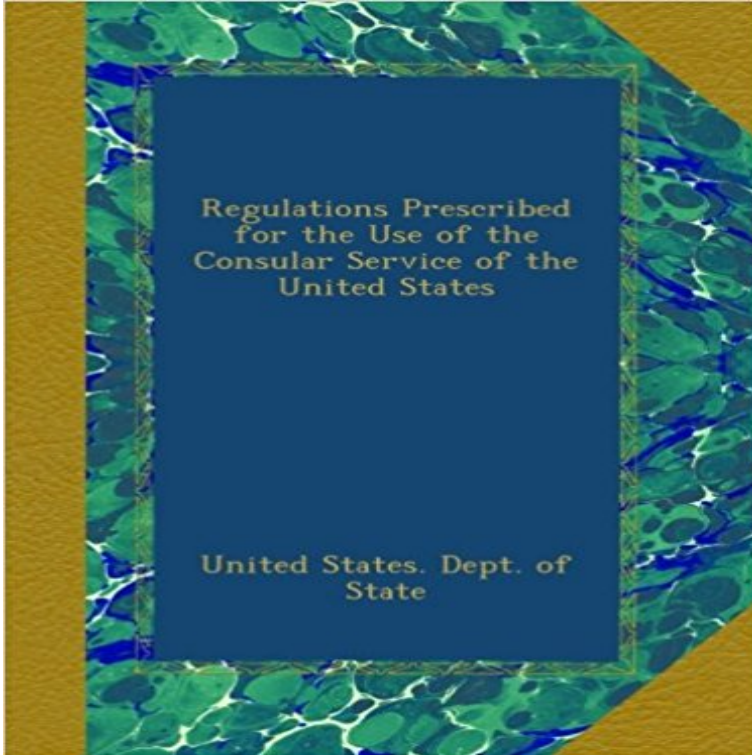


Regulations Prescribed for the Use of the Consular Service of the United States
