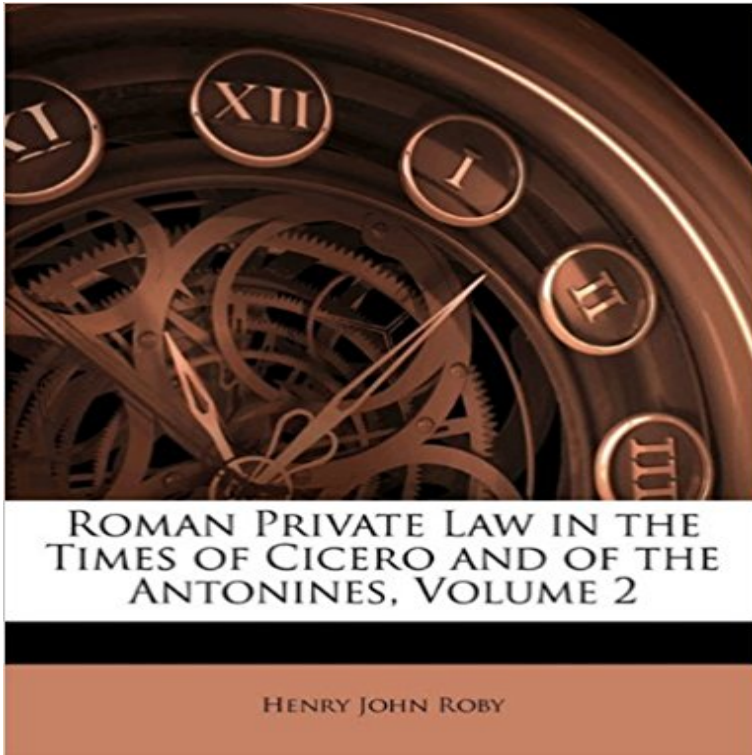


# Roman Private Law in the Times of Cicero and of the Antonines, Volume 2
