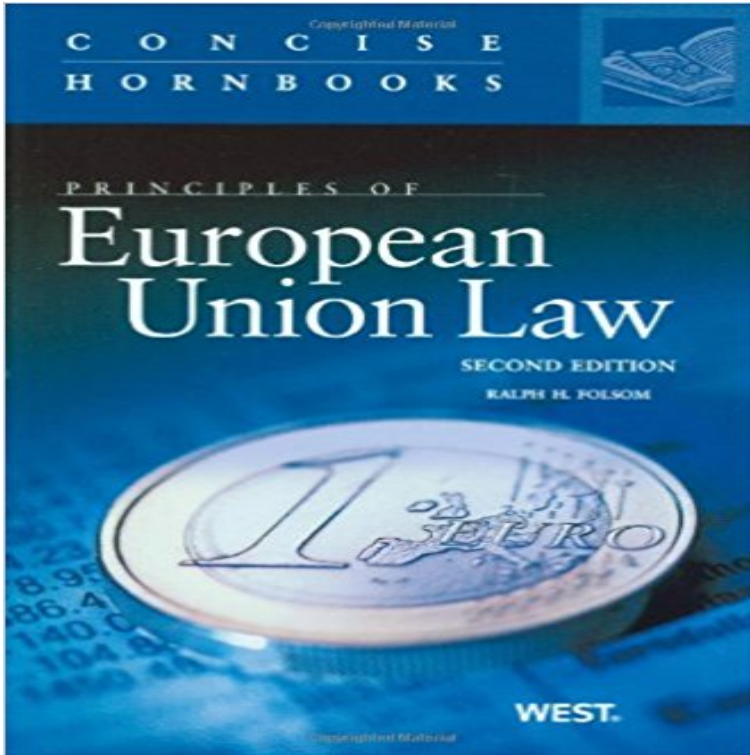


# Principles of European Union Law, 2nd Edition, The Concise Hornbook Series
