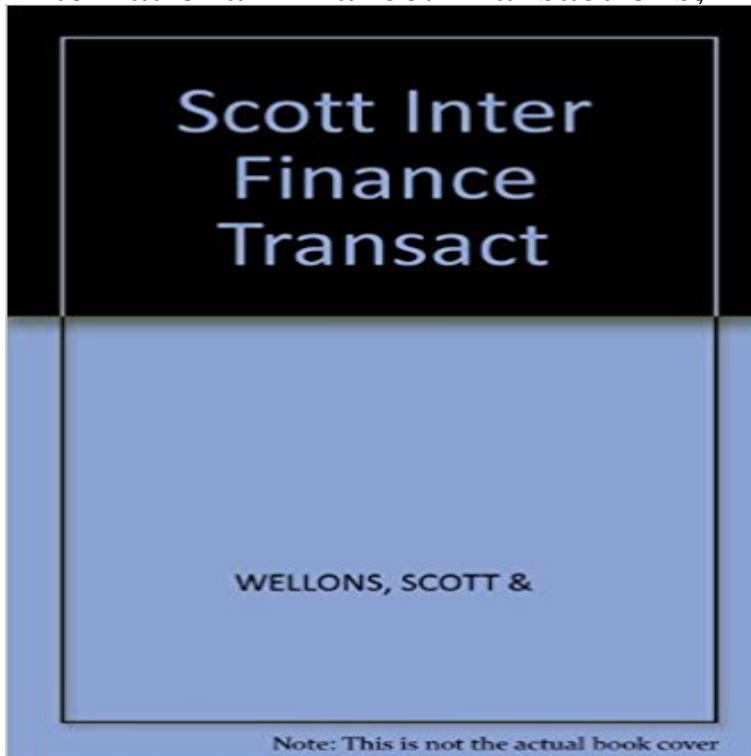


# International Finance: Transactions, Policy and Regulation
