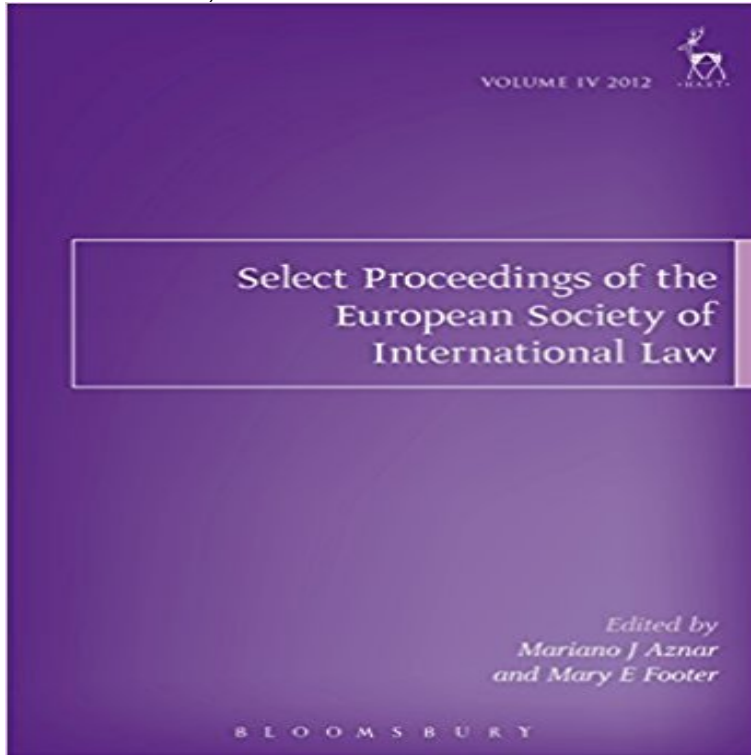


## Select Proceedings of the European Society of International Law, Volume 4, 2012
