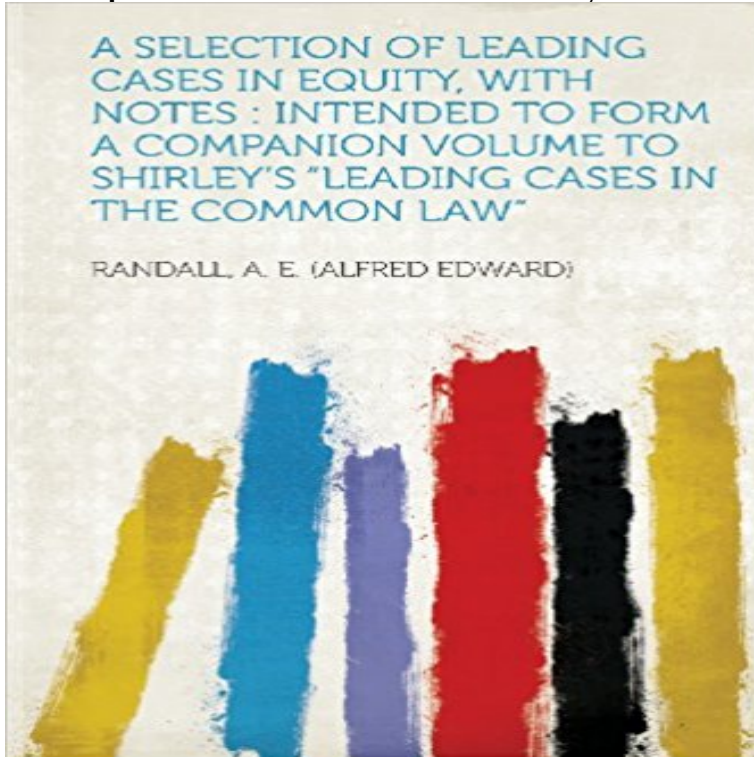


A Selection of Leading Cases in Equity, with Notes: Intended to Form a Companion Volume to Shirleys Leading Cases in the Common Law
