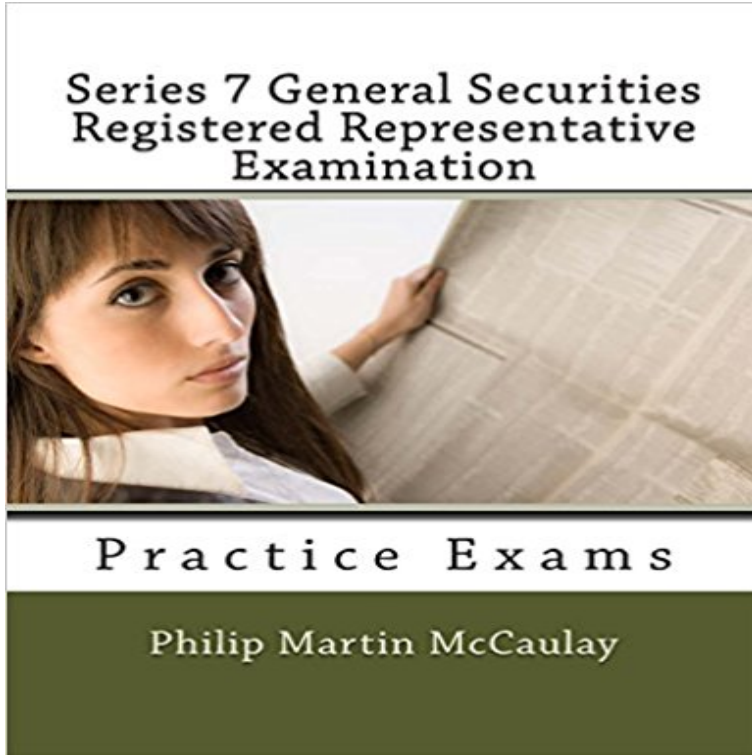


# Series 7 General Securities Registered Representative Examination Practice Exams
