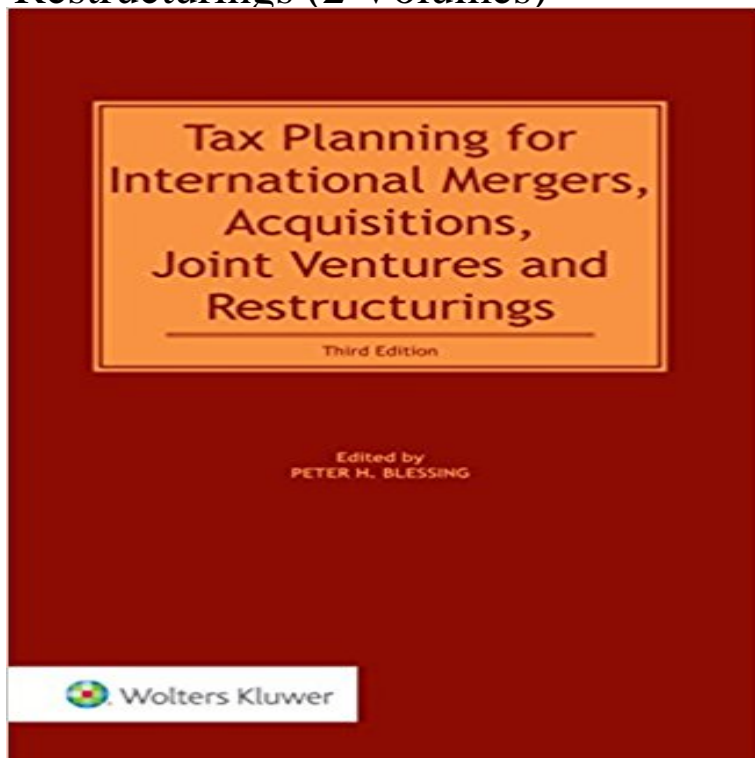


## Tax Planning for International Mergers, Acquisitions, Joint Ventures and Restructurings (2 Volumes)
