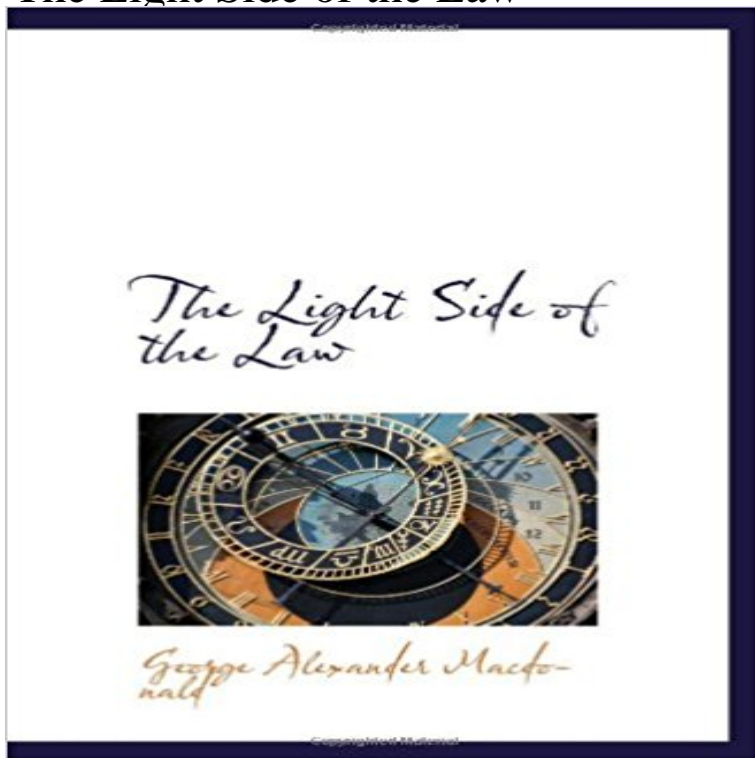


# The Light Side of the Law
