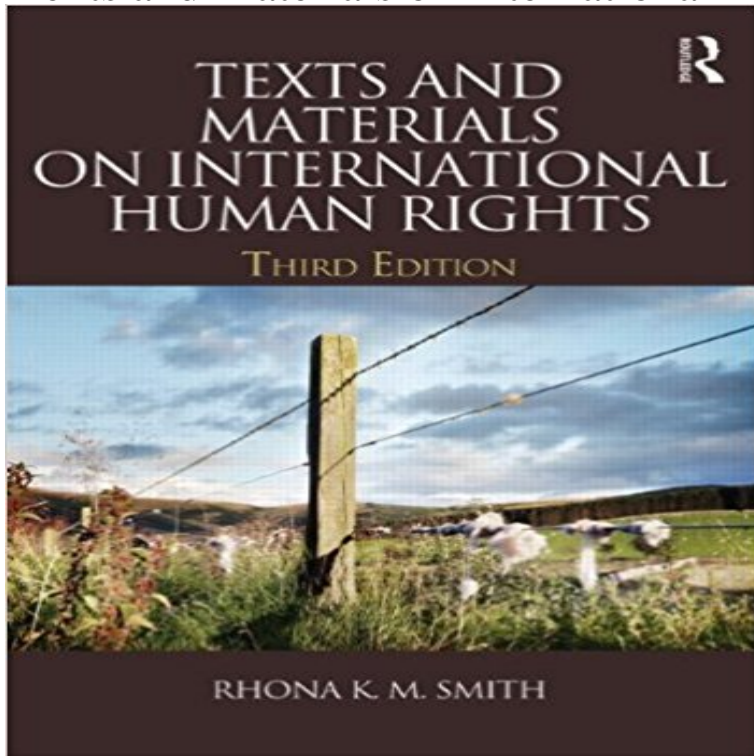


Texts and Materials on International Human Rights
