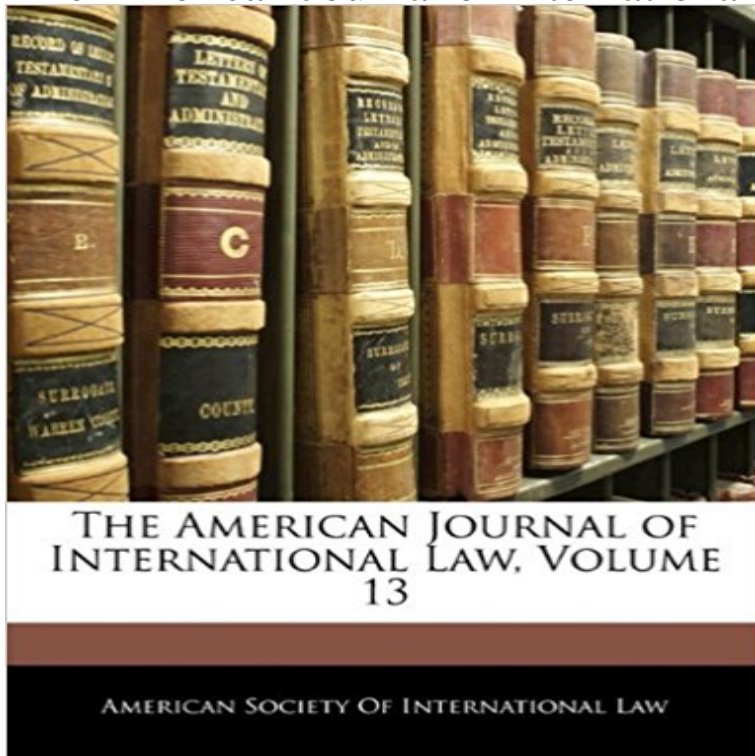


## The American Journal of International Law, Volume 13
