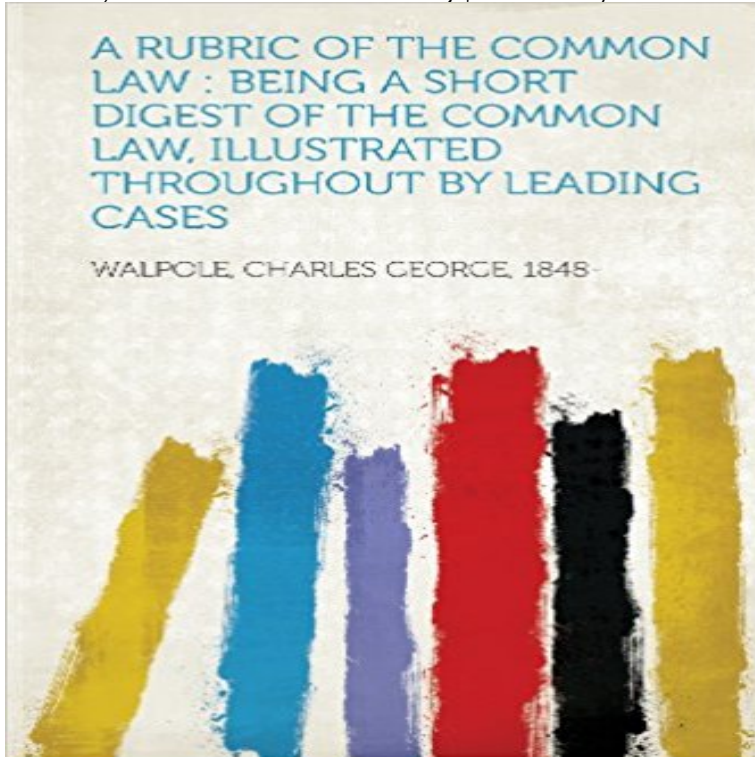


A Rubric of the Common Law: Being a Short Digest of the Common Law, Illustrated Throughout by Leading Cases
