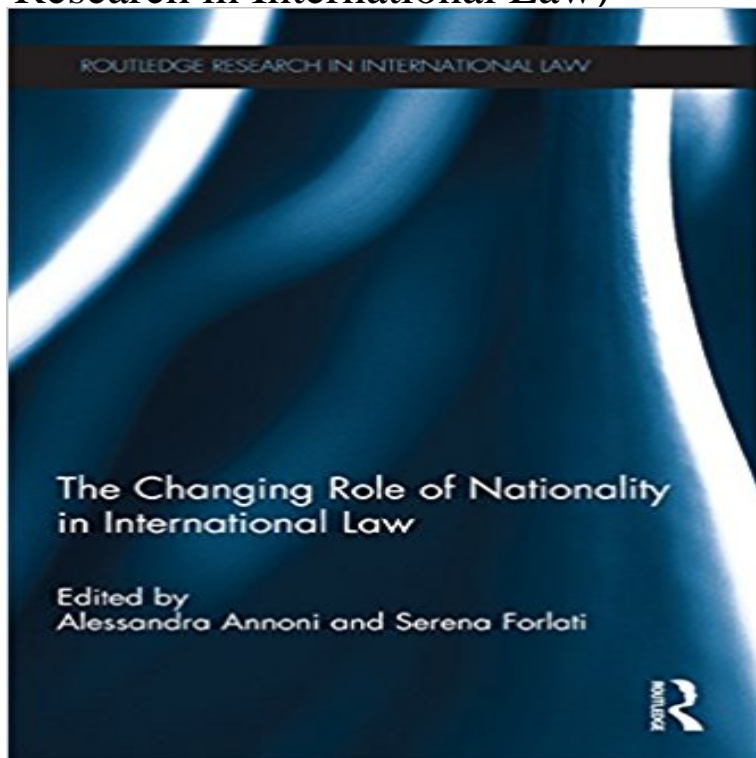


The Changing Role of Nationality in International Law (Routledge Research in International Law)
