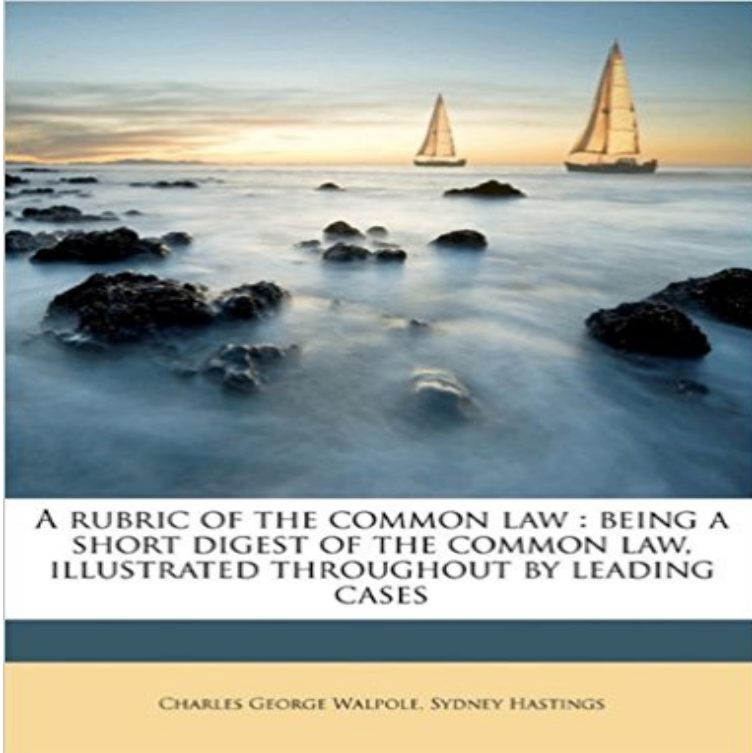


## A rubric of the common law: being a short digest of the common law, illustrated throughout by leading cases
