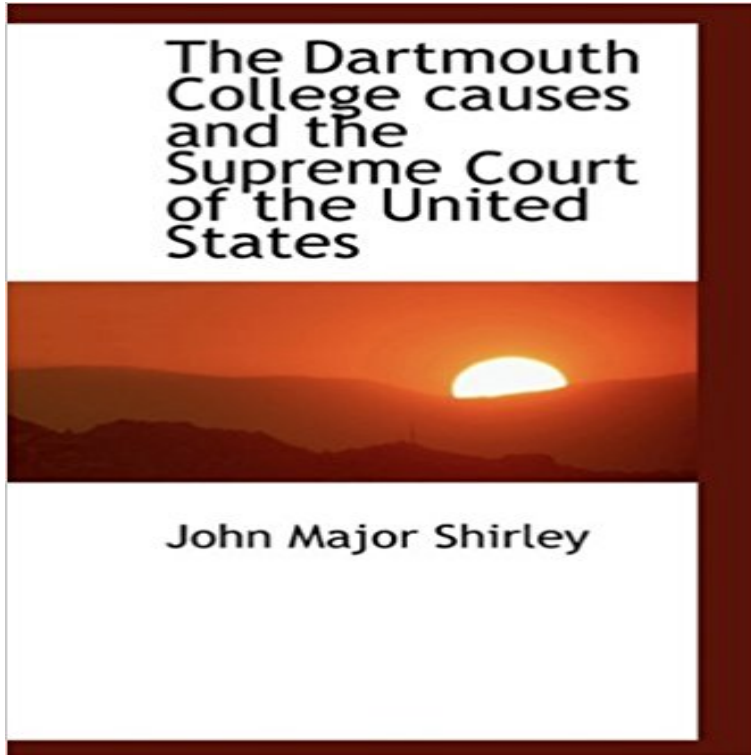


# The Dartmouth College causes and the Supreme Court of the United States
