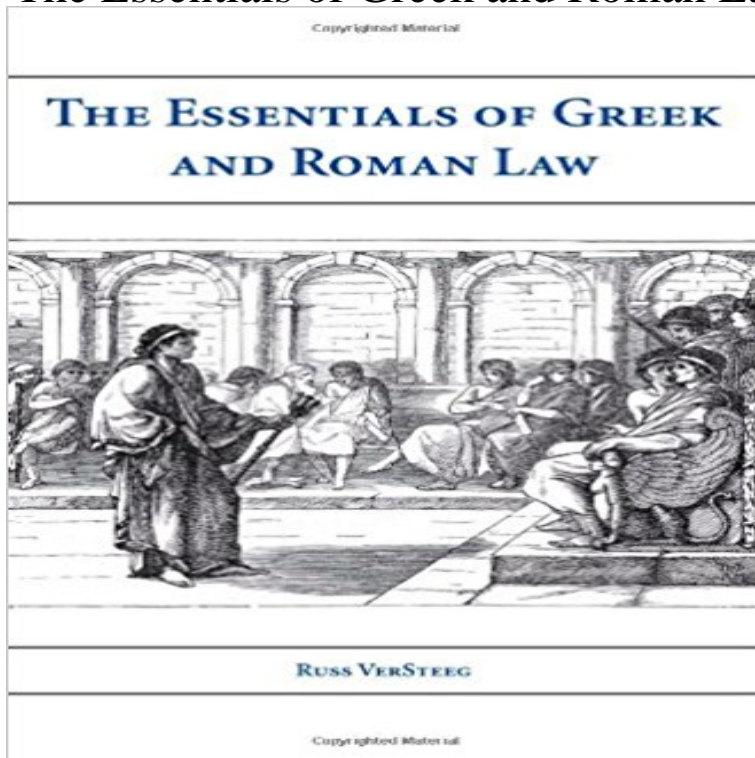


# The Essentials of Greek and Roman Law
