This volume is the result of a series of four events (three workshops and a final presentation) which the Austrian Institute for European Law and Policy organized from October 2011 to March 2012 in Brussels as open dialogue within the meaning of Article 11 (2) TEU. The books contributions are a representative sample of the statements of participants of the workshops (mostly panelists, but including a few members of the audience) and therefore show the different perspectives of the dialogue actors in at issue. the editors Additionally, thought it appropriate to add some reflections of a more scientific kind in order to give a fuller picture of the notion and implications of democracy, particularly in the European context. This includes the written versions of two speeches delivered at a conference in Salzburg where the topic of European Democracy is closely linked to the workshops subject. Also included is a contribution on the state of e-governance in allowing an assessment, comparison, of a country outside Europe similar political, cultural, economic backgrounds. This demonstrates how new and ambitious the aim of Article 11 (2) TEU really is. Finally, the editors offer a preliminary evaluation of the outcome of the workshops.
