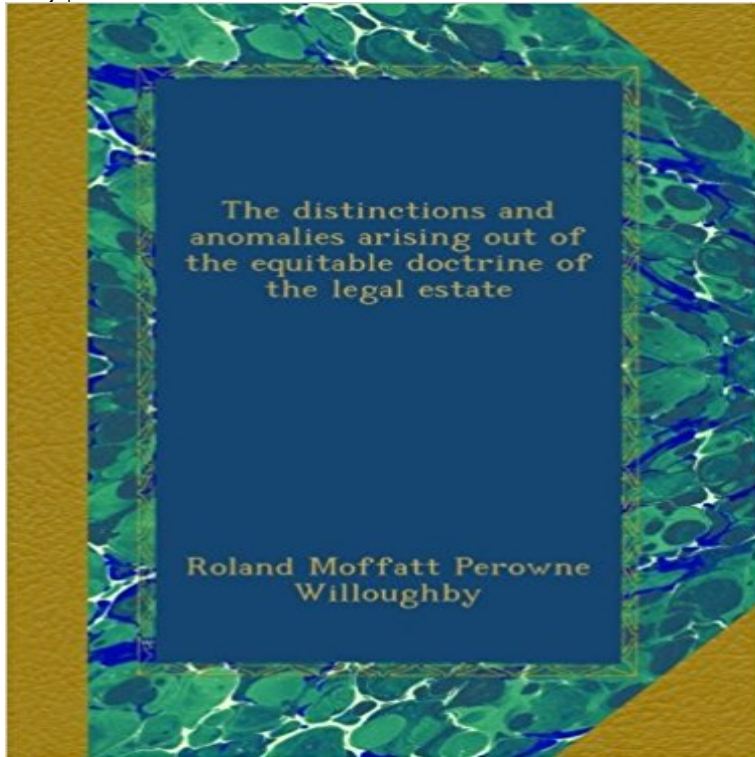


The distinctions and anomalies arising out of the equitable doctrine of the legal estate
