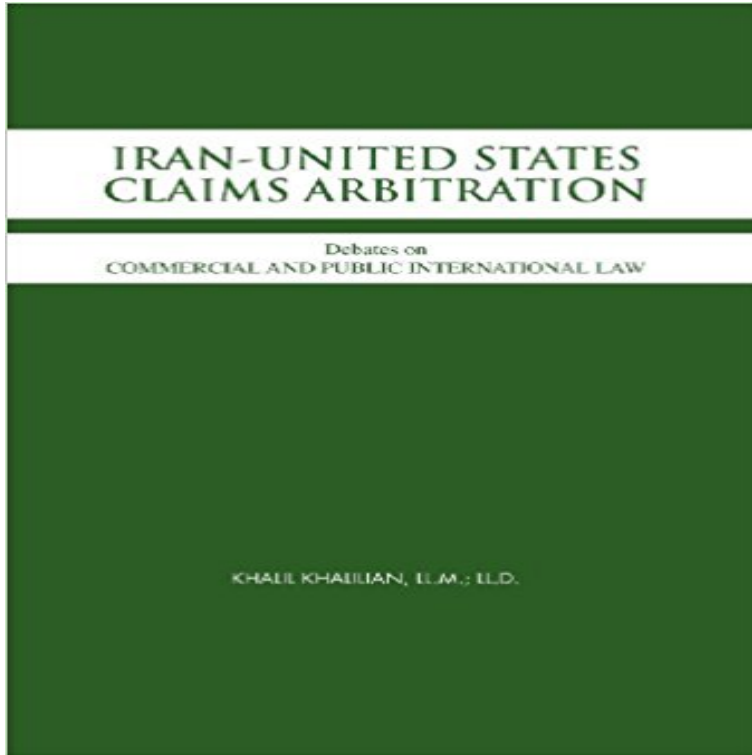


# Iran-United States Claims Arbitration: Debates on Commercial and Public International Law
