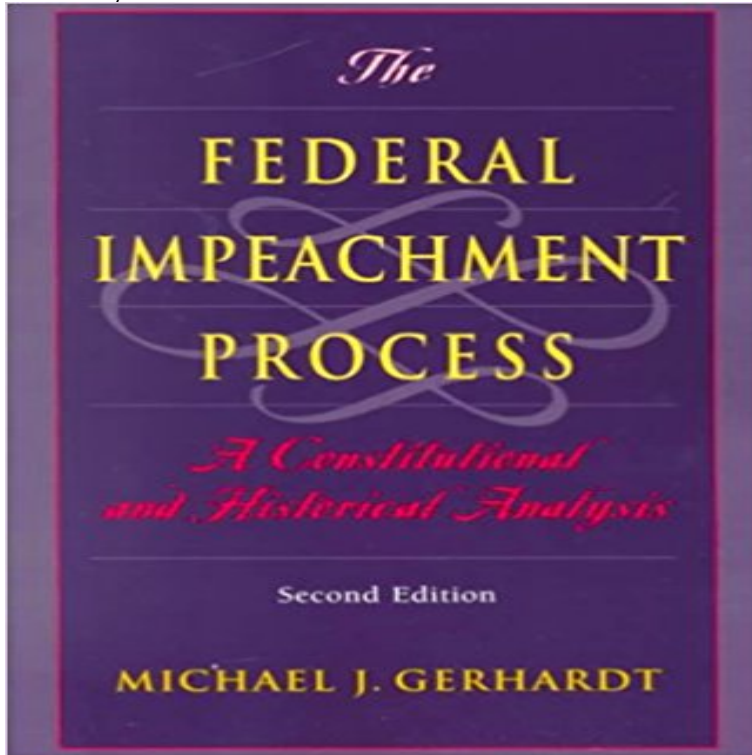


The Federal Impeachment Process: A Constitutional and Historical Analysis
