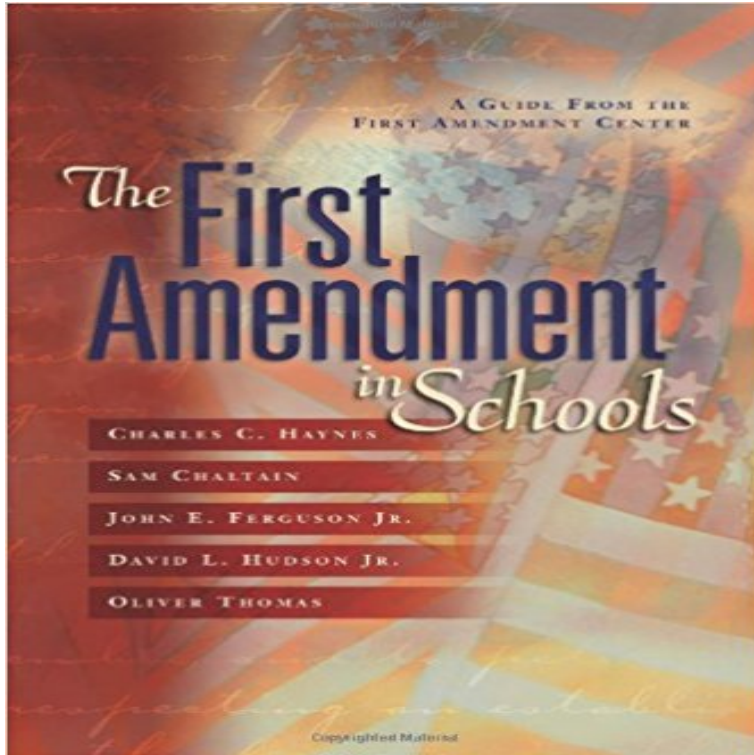


# The First Amendment in Schools: A Guide from the First Amendment Center
