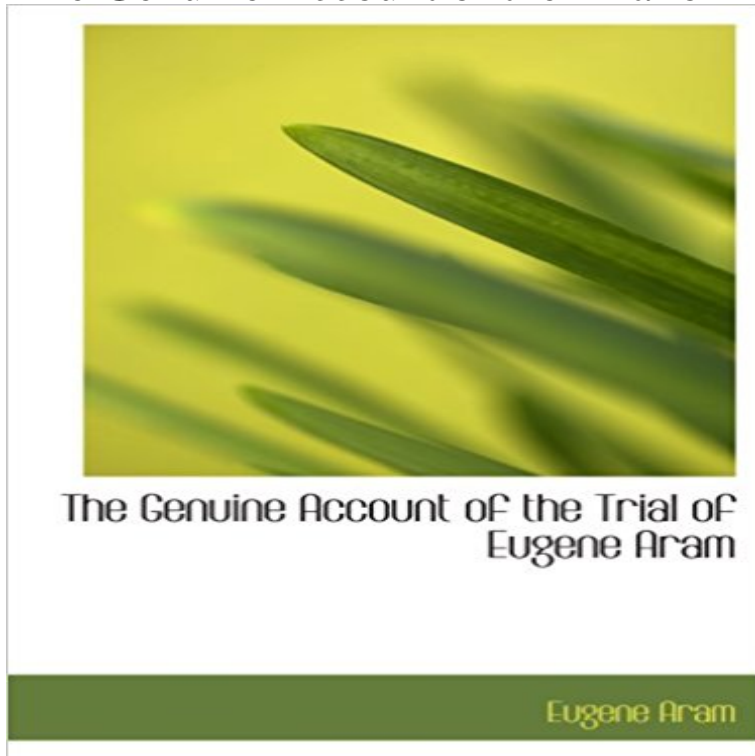


# The Genuine Account of the Trial of Eugene Aram
