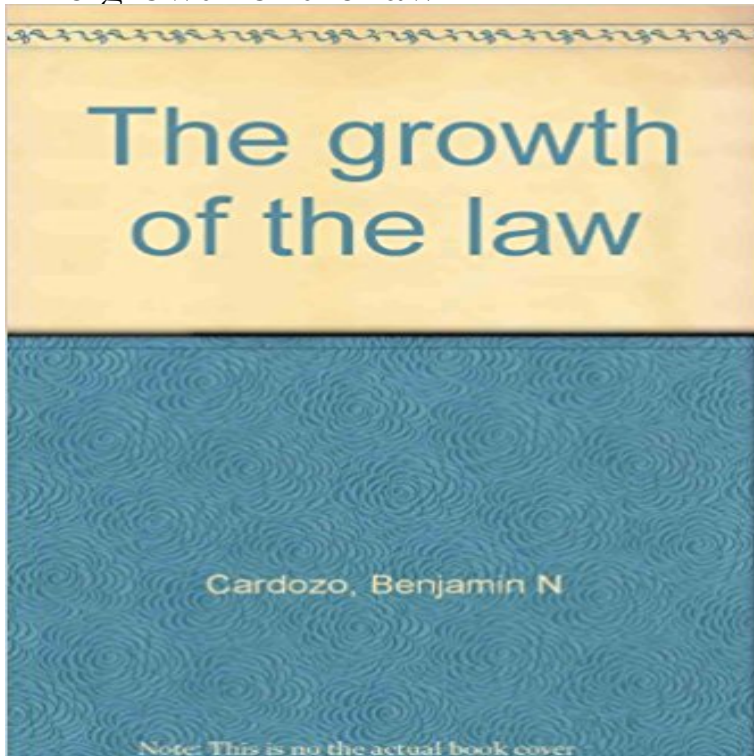


## The growth of the law
