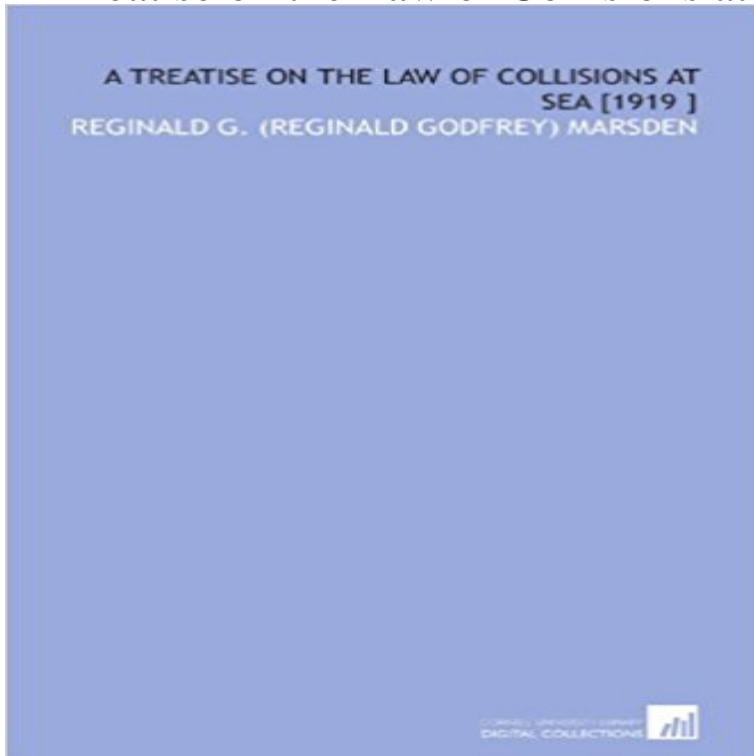


## A Treatise on the Law of Collisions at Sea [1919 ]
