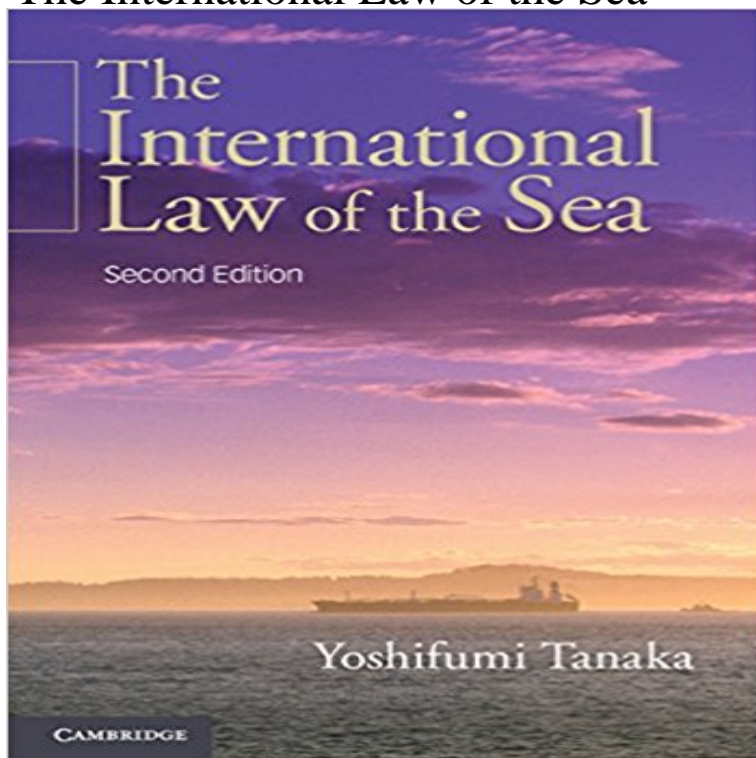


The International Law of the Sea
