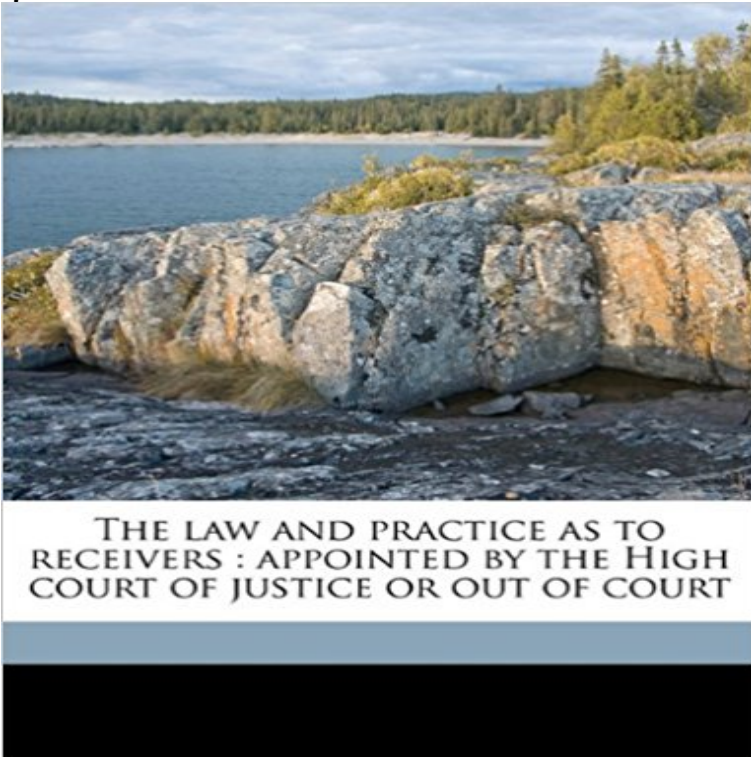


# The law and practice as to receivers: appointed by the High court of justice or out of court
