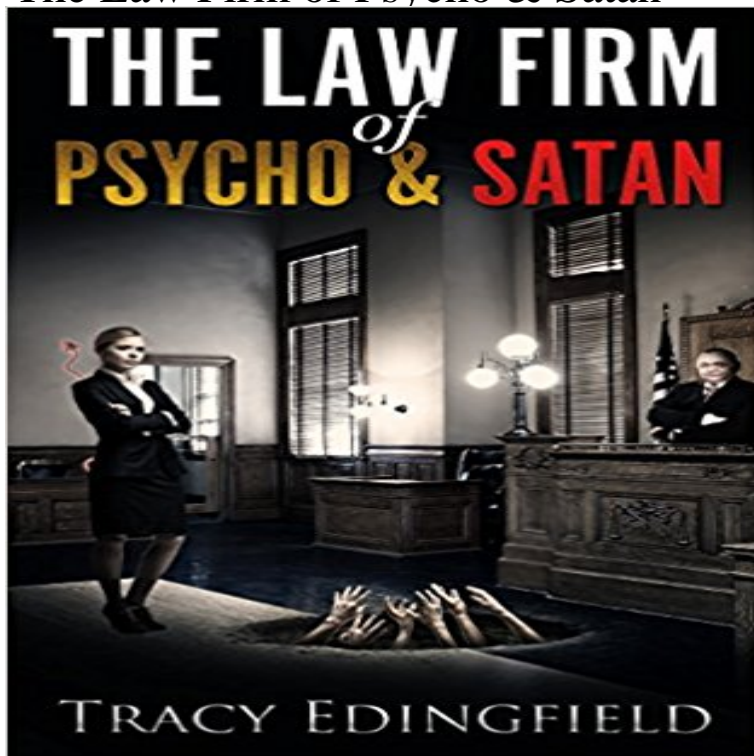


The Law Firm of Psycho & Satan
