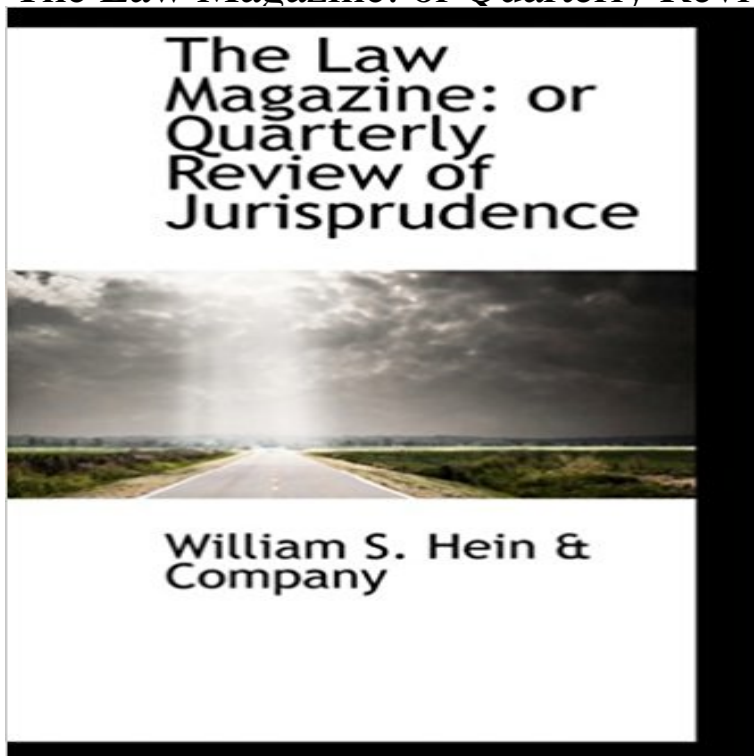


The Law Magazine: or Quarterly Review of Jurisprudence
