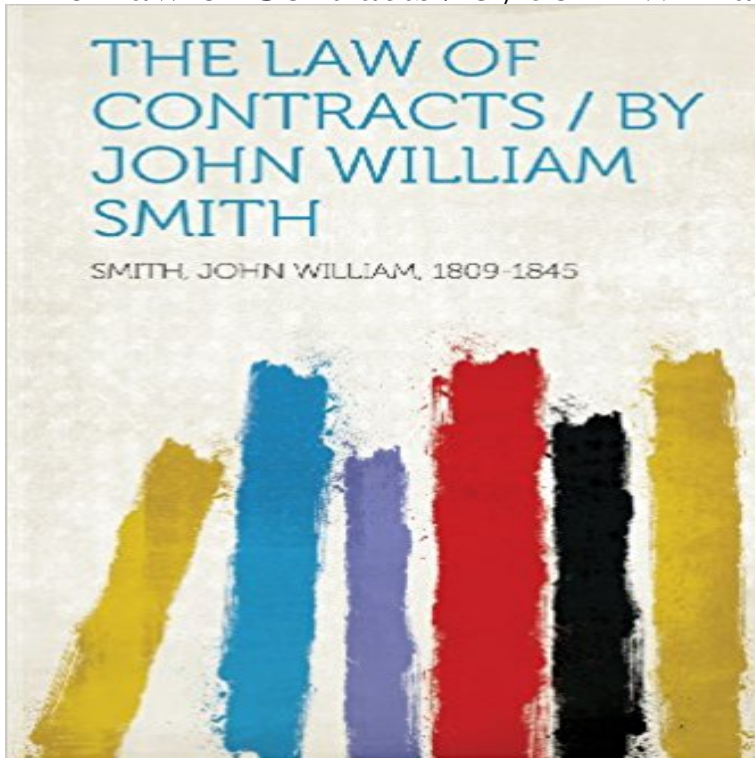


The Law of Contracts / by John William Smith
