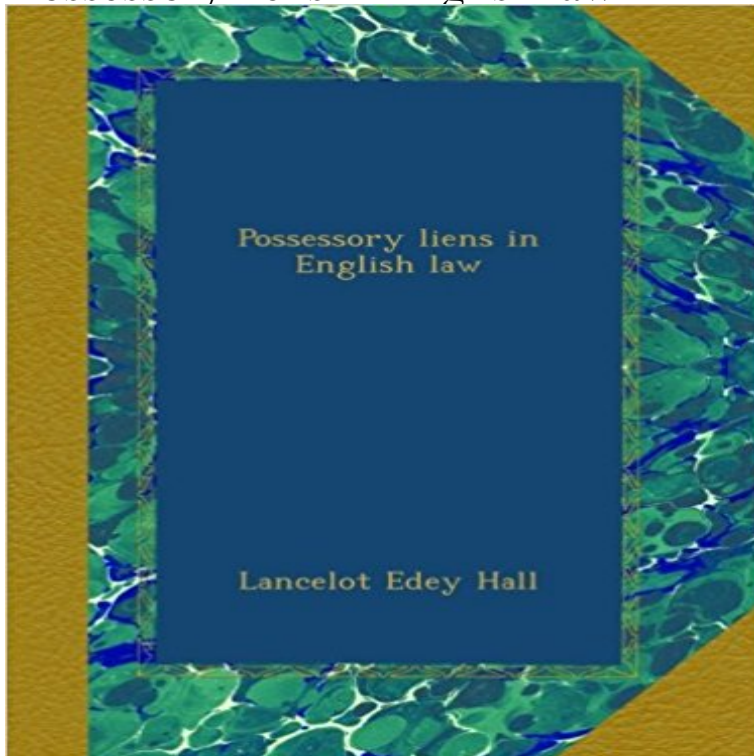


## Possessory liens in English law
