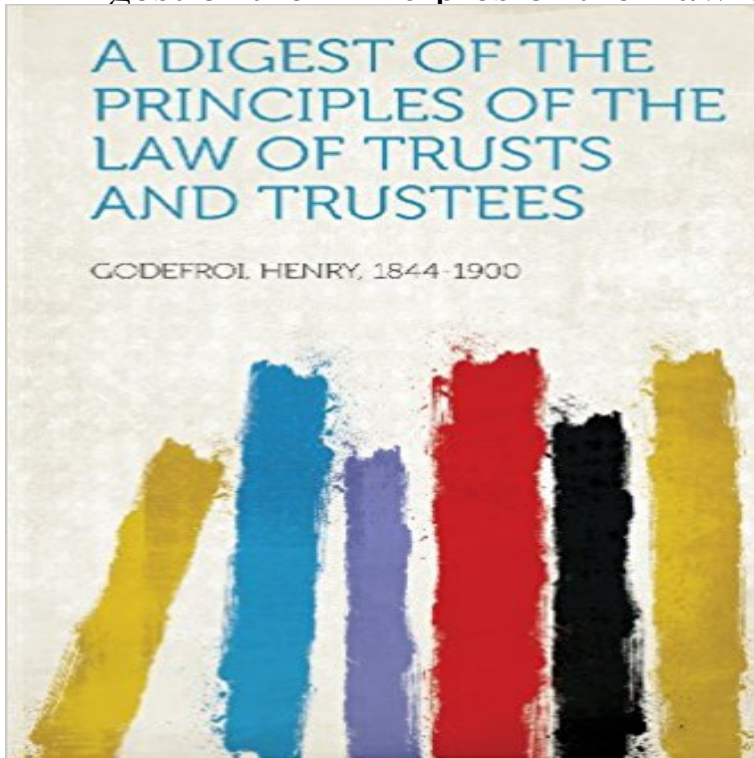


# A Digest of the Principles of the Law of Trusts and Trustees
