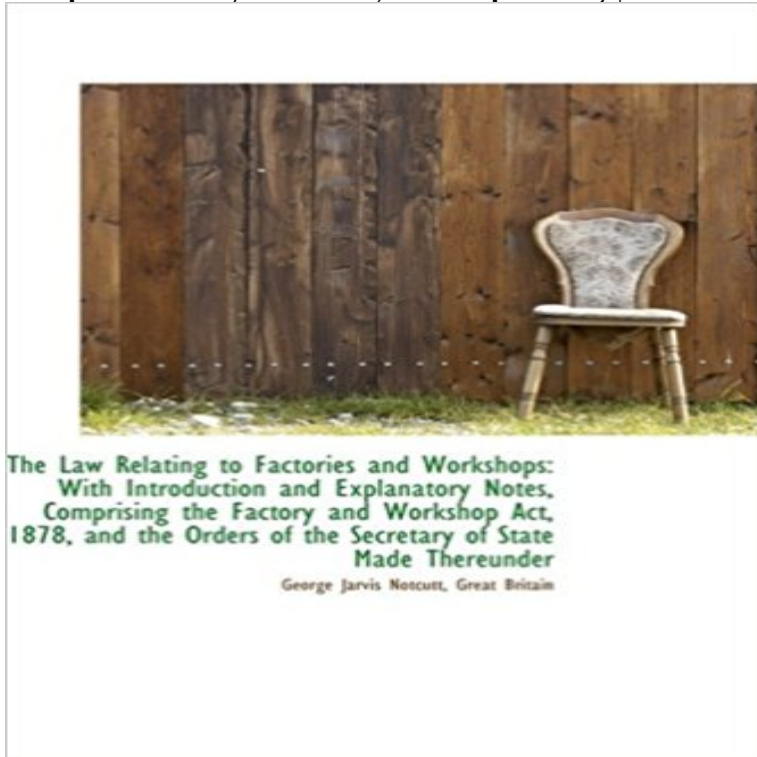


# The Law Relating to Factories and Workshops: With Introduction and Explanatory Notes, Comprising the
