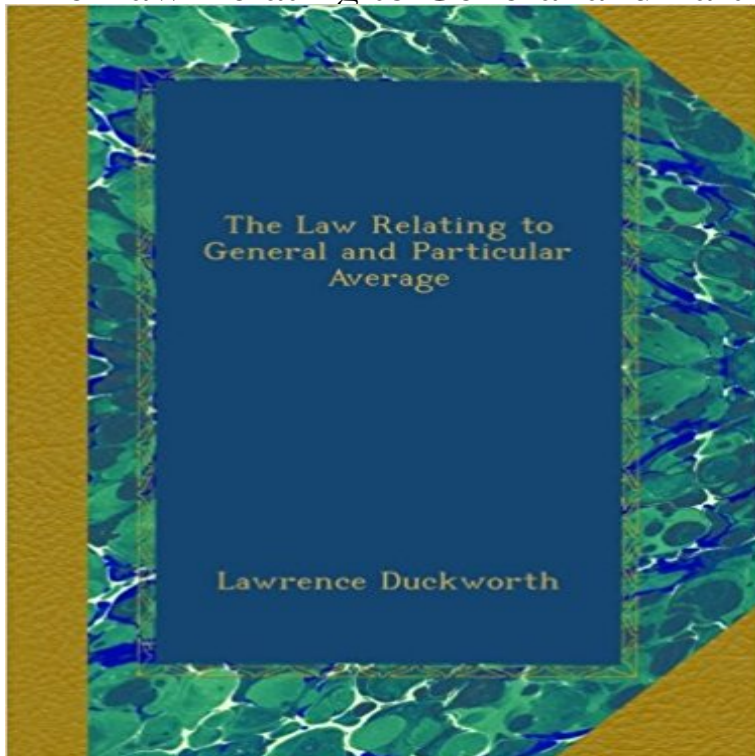


# The Law Relating to General and Particular Average
