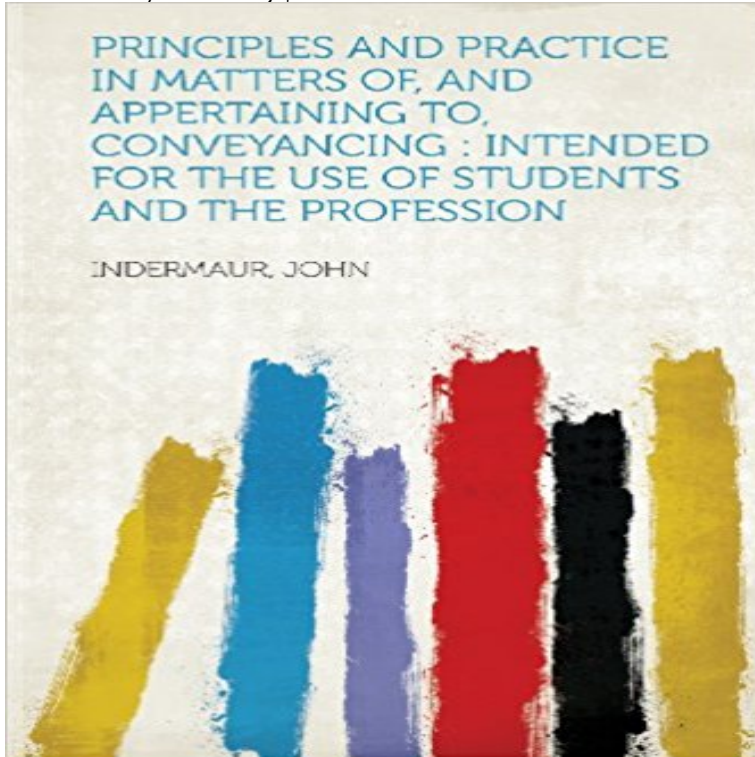


# Principles and Practice in Matters Of, and Appertaining To, Conveyancing: Intended for the Use of Students and the Profession
