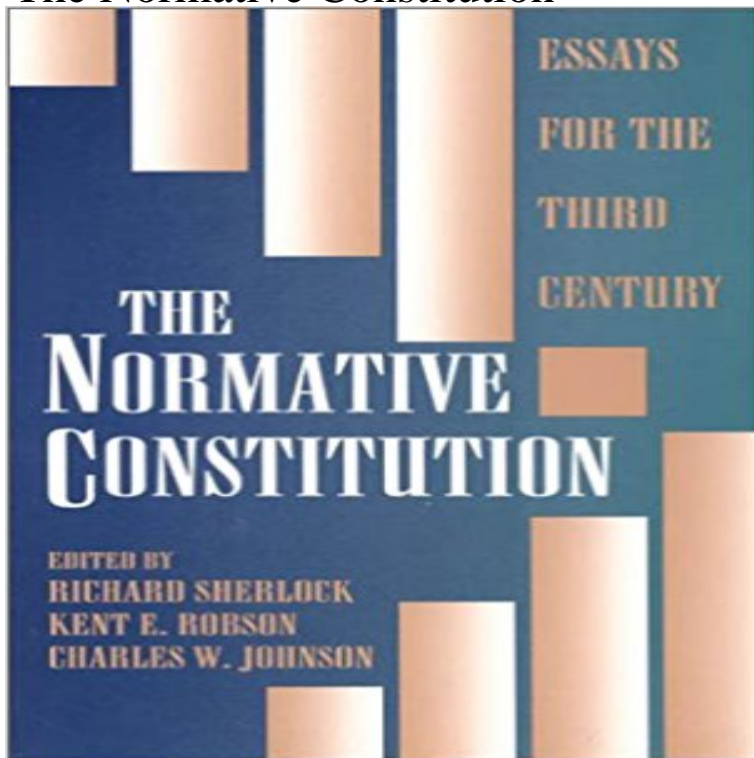


The Normative Constitution
