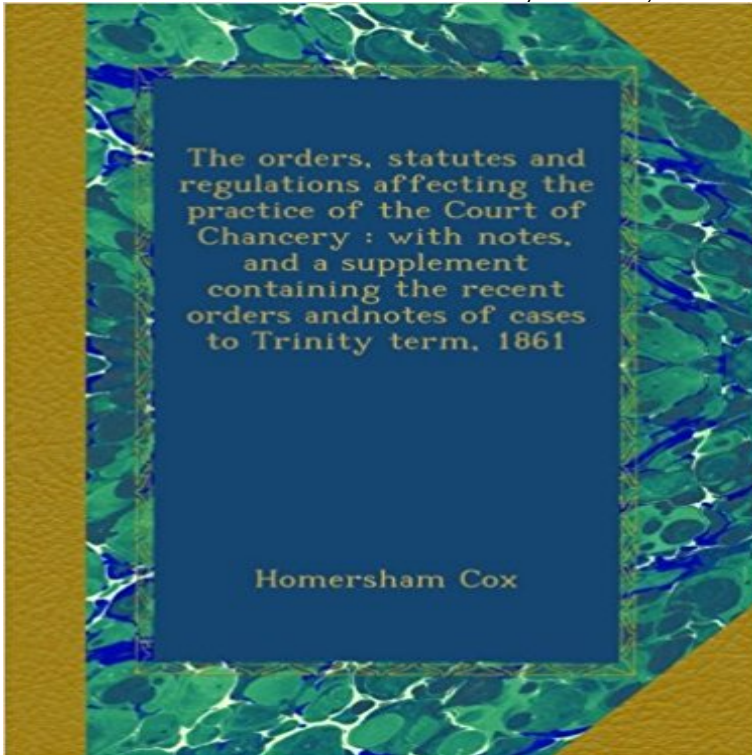


The orders, statutes and regulations affecting the practice of the Court of Chancery : with notes, and a supplement containing the recent orders and notes of cases to Trinity term, 1861
