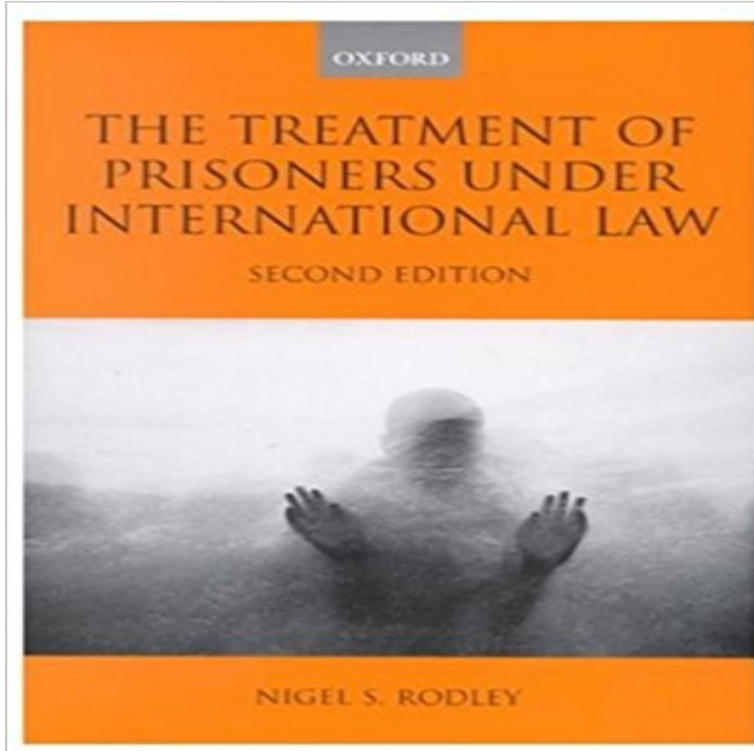


The Treatment of Prisoners Under International Law
