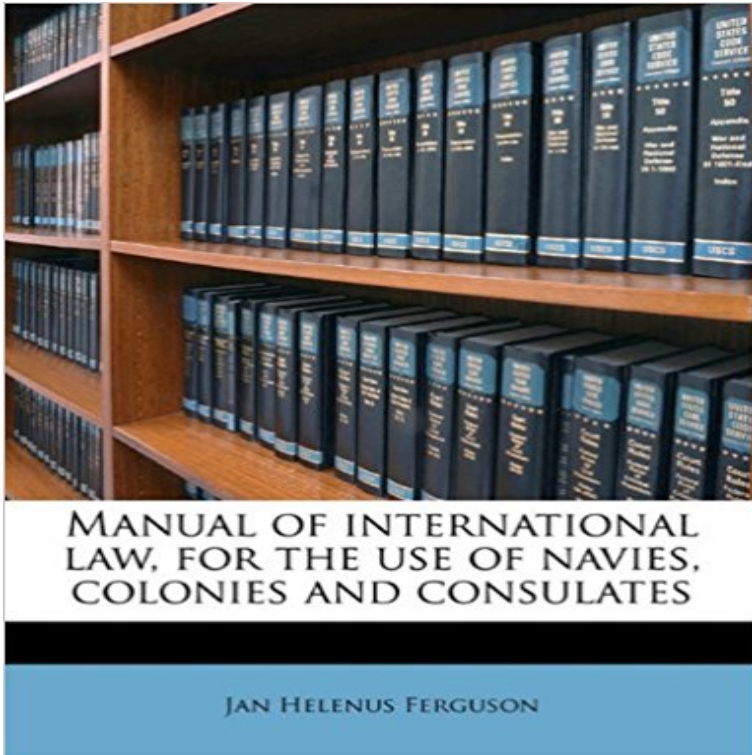


# Manual of international law, for the use of navies, colonies and consulates Volume 1
