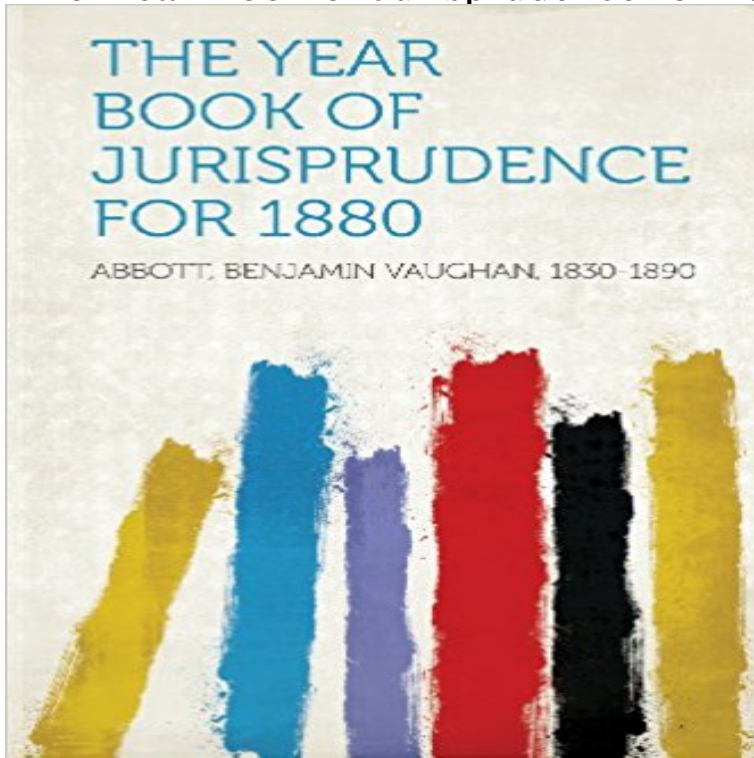


## The Year Book of Jurisprudence for 1880
