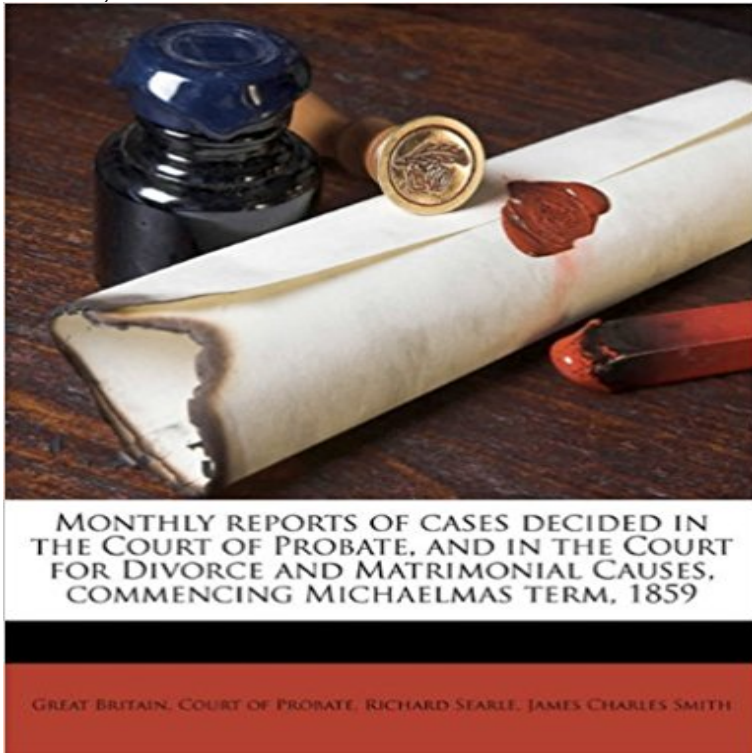


# Monthly reports of cases decided in the Court of Probate, and in the Court for Divorce and Matrimonial Causes, commencing Michaelmas term, 1859
