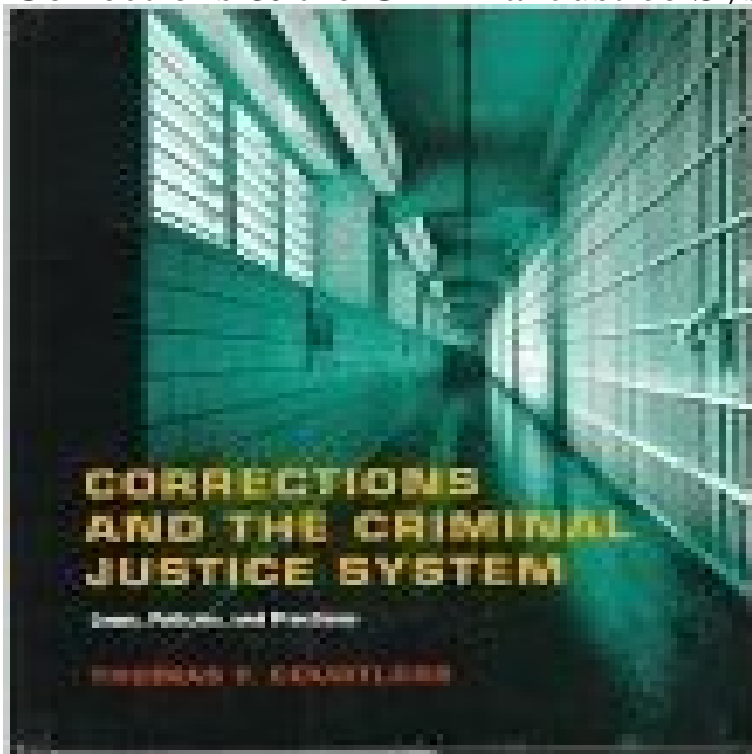


Corrections & the Criminal Justice System (Criminal Justice Ser)
