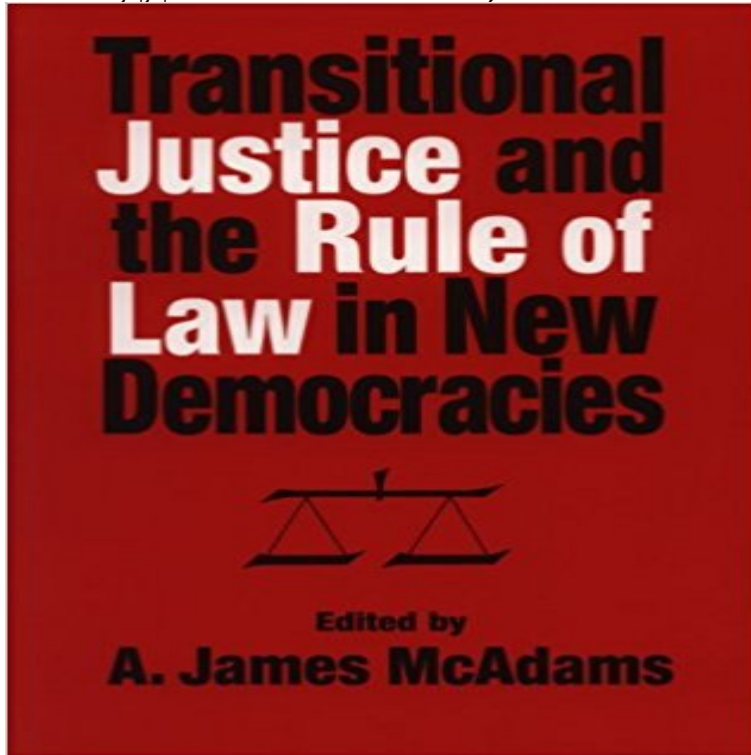


## Transitional Justice and the Rule of Law in New Democracies (ND Kellogg Inst Intl Studies)
