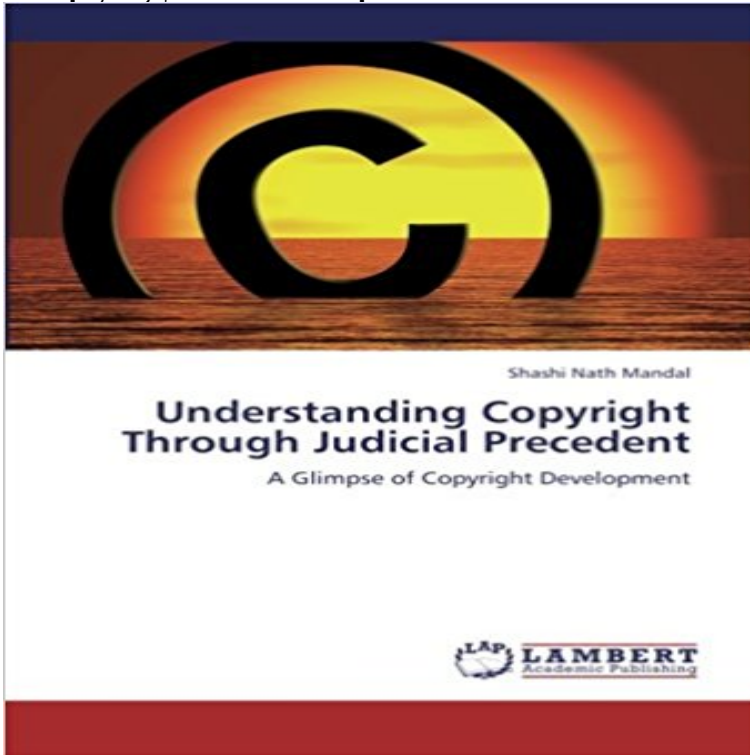


Understanding Copyright Through Judicial Precedent: A Glimpse of Copyright Development
