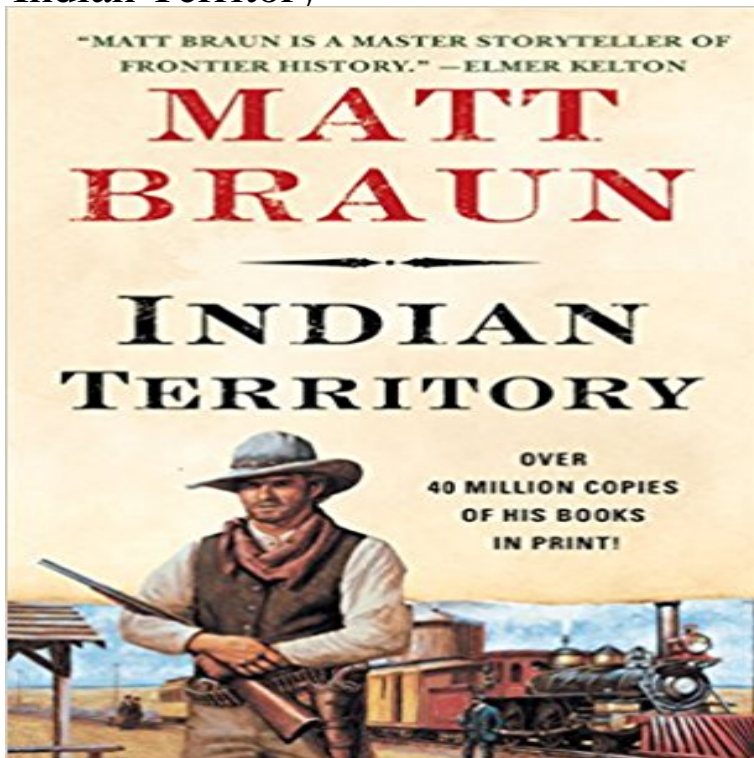


Indian Territory
