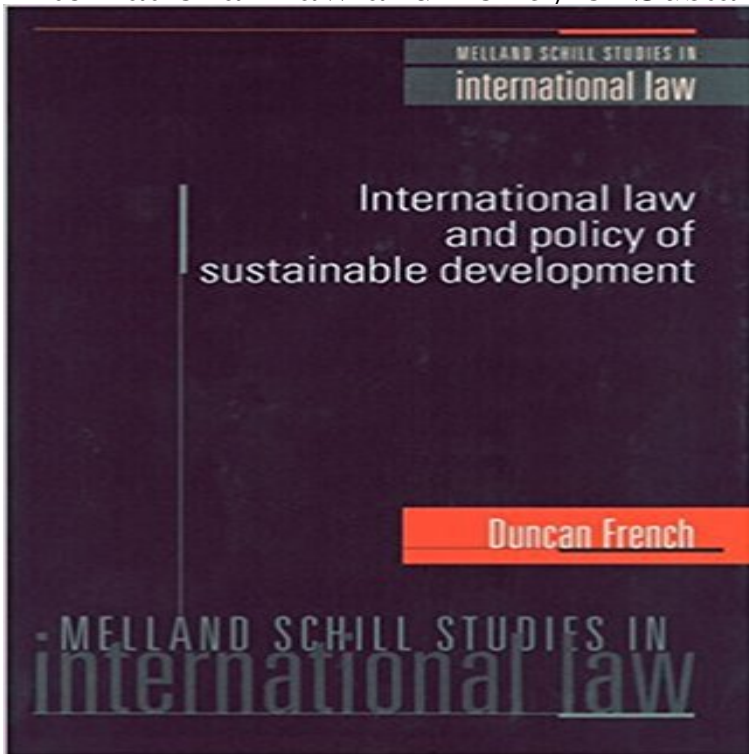


# International Law and Policy of Sustainable Development
