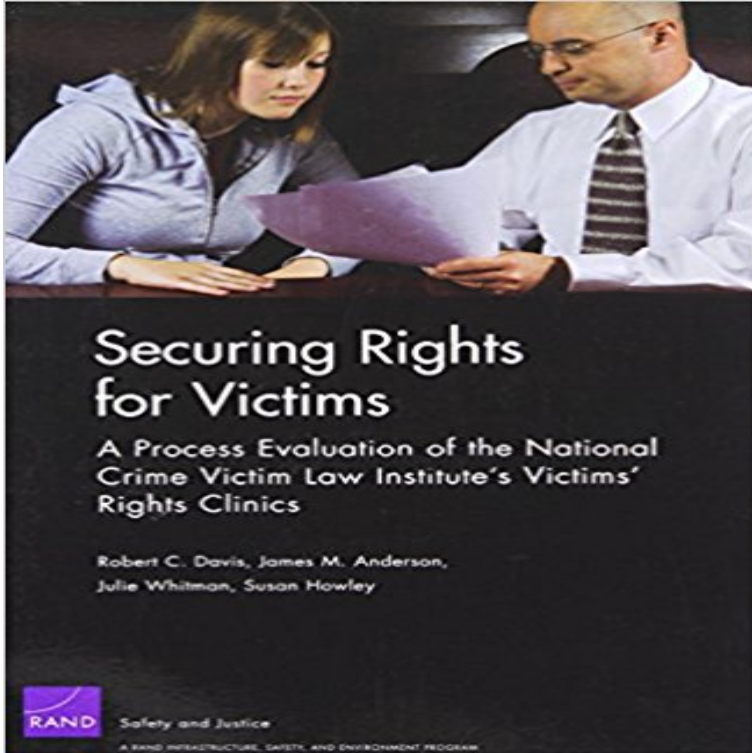


# Securing Rights for Victims: A Process Evaluation of the National Crime Victim Law Institutes Victims Rights Clinics
