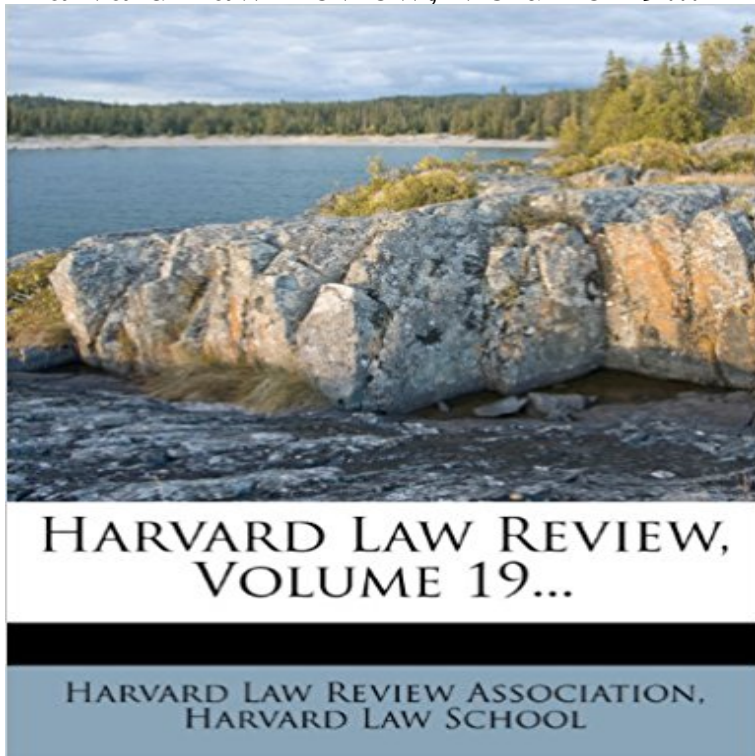


## Harvard Law Review, Volume 19...
